

Note to All Exhibitors: It is the RESPONSIBILITY OF THE 4-HER AND HIS OR HER PARENT OR GUARDIAN to complete all 4HOnline Animal ID and submit any paperwork required for their project by May 15th. Late and/or incomplete information will eliminate the member from exhibition!

#### Companion Animals/Small Animals:

- A. Cats Please complete the enclosed "Porter County 4-H Cat ID Form". It is important to be accurate and to complete all information. *Animals not listed on this form by May 15<sup>th</sup> will not be eligible to be shown at this year's Porter County Fair.* Please list any cats/kittens you wish to have eligible for the fair.
- B. Dogs Complete the enclosed "Porter County 4-H Dog ID Form". It is important to be accurate and to complete all information. *Animals not listed on this form by May 15<sup>th</sup> will not be eligible to be shown at this year's county fair.* In addition to this form, Dog project members must also attend at least one of their five suggested workshops no later than the first workshop following May 15<sup>th</sup>. Please list any dogs you wish to have eligible for the fair. (4-Hers may show and train a maximum of two dogs at different levels, which must be declared during the online FairEntry process, announced in early June and due June 25<sup>th</sup>.)
- C. Pigeons Please complete the enclosed "Porter County 4-H Pigeon ID Form". It is important to be accurate and to complete all information. *Animals not listed on this form by May 15<sup>th</sup> will not be eligible to be shown at this year's Porter County Fair.* Please list any pigeons you wish to have eligible for the fair. (Final declaration of animals/classes to be exhibited at the fair must be declared via the FairEntry process by June 25<sup>th</sup>. More information on this process will be announced in June.)

#### **Livestock Animals/Large Animals:**

- A. Beef\* Registered Heifers not previously entered into 4HOnline must be in the system by May 15<sup>th</sup>. For the county fair, registered heifers must be identified by a 15-digit 840-RFID tag **AND** tattoo. Additionally, to be eligible for State Fair they must submit a DNA hair sample to the Extension Office by May 15<sup>th</sup>. For instructions on completing 4HOnline Animal ID, go to https://bit.ly/2024AnimalID. DNA hair sample collection envelopes are available from the Extension Office.
- B. Dairy\* To be eligible for exhibition, dairy cattle must be entered into 4HOnline by May 15<sup>th</sup>. To be eligible for county and state fairs, registered cattle must be identified by 840-RFID tag **AND** registered name **AND** registration number or dam's registration number. Additionally, to be eligible for State Fair they must submit a DNA hair sample to the Extension Office by May 15<sup>th</sup>. Unregistered dairy cattle must be identified by ear tag. DNA hair sample collection envelopes are available from the Extension Office.
- C. Dairy Feeder Steers\* To be eligible for exhibition, dairy feeder steers must be entered into 4HOnline by May 15<sup>th</sup>. Dairy feeder steers must be identified by a 15-digit 840-RFID tag AND 5-digit county ear tag number. Please complete the top of the enclosed worksheet and bring it with you on ID day, which is May 4<sup>th</sup> at 9:00 a.m. Your project volunteers will record the information gathered at ID Day so that you can take the information home with you and enter the information into 4HOnline. For instructions on completing 4HOnline Animal ID, go to <a href="https://bit.ly/2024AnimalID">https://bit.ly/2024AnimalID</a>.
  - \* Official Cattle ID in Indiana Board of Animal Health (BOAH): Cattle must have an "official ID" to adhere to BOAH regulations. The "official ID" does not include our yellow 5-digit 4-H tag (which is required for 4-H), but it does include an 840/USDA tag. So those who have both their yellow 5-digit tag and an "official" 840/USDA tag are compliant with both 4-H and BOAH.
  - If your cattle have NOT been tagged with an 840/USDA tag and will be attending an open show prior to the Porter County Fair, you will need to be compliant with these BOAH guidelines on "official ID" for exhibition.   - Upon arrival at the Porter County Fair, any non-terminal cattle that do not yet have an 840/USDA tag will be tagged during the fair check-in process. Additionally, all feeder steers will be tagged with both the 5-digit 4-H tag and the 840/USDA tag on ID day.
- D. Equine (Including Horse & Pony, Miniature Equine, and Draft Horse) To be eligible for exhibition, animals must be entered into 4HOnline by May 15<sup>th</sup>. Before you go onto 4HOnline, be sure you have color photos ready to upload that clearly show facial and leg markings. If you lease your horse, you and the owner may draw up a lease on your own, or for your convenience 4-H Animal Lease Agreement Forms are available at: <a href="https://bit.ly/2024AnimalID">https://bit.ly/2024AnimalID</a>. Please sign up all horses available to be exhibited at the fair, including backup horses.



# ANIMAL PROJECT INFORMATION

E. Goats – See table below for required identification. All unregistered females and all wethers will be weighed and ear-tagged at ID Day on May 10<sup>th</sup> (6:00-8:00 pm). To be eligible for exhibition, goats must then be entered into 4HOnline by May 15<sup>th</sup>. For instructions on completing 4HOnline Animal ID, go to <a href="https://bit.ly/2024AnimalID">https://bit.ly/2024AnimalID</a>. Please complete the top of the enclosed worksheet and bring it with you to ID Day. Your project volunteers will record the information gathered at ID day so that you can take the information home and enter the information into 4HOnline. If you lease your 4-H project goats, you must have a signed lease agreement on file in the Extension Office by May 15<sup>th</sup>. (We encourage you to bring it with you and turn it in at ID day.) You and the owner may draw up a lease on your own, or for your convenience, 4-H Animal Lease Agreement Forms are available at: <a href="https://bit.ly/2024AnimalID">https://bit.ly/2024AnimalID</a>.

Dairy Goat - Registered Females	Breed registry tattoo
Dairy Goat – Unregistered Females	5-digit county tag (LaMancha: official Scrapie flock tattoo in the tail web along with a number unique to the animal (usually on the opposite side). Obtain number from the Indiana Board of Animal Health (BOAH). BOAH can provide a shorter format for the Scrapie flock ID to fit in the small tail web.) Tatoo must be done before you come to Tag day
Dairy Goat - Wethers	5-digit county tag (LaMancha: official Scrapie flock tattoo in the tail web along with a number unique to the animal (usually on the opposite side). Obtain number from the Indiana Board of Animal Health (BOAH). BOAH can provide a shorter format for the Scrapie flock ID to fit in the small tail web.) Tatoo must be done before you come to Tag day
*Meat Goat - Wethers & Unregistered Females	840-RFID tag *AND* 5-digit county tag
*Meat Goat - Registered Boer Females	Breed registry tattoo
Pygmy Goat - Registered	Breed registry tattoo *OR* 5-digit county tag
Pygmy Goat - Unregistered	Official USDA Scrapie tag *OR* official Scrapie tattoo
Pygmy/Specialty Goat - Wether	5-digit county tag

\*\*NOTE: For Meat Goat – Wethers and Meat Goat – Registered Boer Females a DNA hair sample is required for State Fair eligibility. No DNA hair sample required for County Fair eligibility.)

<u>Scrapie Eradication Program:</u> Though Scrapie tags are not considered required identification for 4-H animals (with the exception of Pygmy goats), Scrapie tags are a requirement of the United States Department of Agriculture and the Indiana Board of Animal Health. - F. Poultry No location form needed. The Poultry Project does not have paperwork to submit prior to their FairEntry submission. Final declaration of animals/classes to be exhibited at the fair must be declared via the FairEntry process by June 25<sup>th</sup>. More information on this process will be mailed in June.
- G. Rabbits (As approved at the November 2022 Meeting of the Porter County 4H Council, paper forms will be the official Animal ID process for the Porter County Rabbit Project, no online FairEntry will be accepted for Rabbits) To be eligible for exhibition, Rabbits must be listed on the "Porter County 4H Rabbit ID Form" with a tattoo, Breed, Color/Variety, Age and Sex. The "Porter County 4H Rabbit/Meat/Market/Breeding Entry Form" must also be filled out to enter a Meat Pen, Carcass, Doe and Litter and breeding of JRS. Sign and turn in the second form even if you're not participating in Meat or Breeding with the answers to the questions as "No". <u>Both</u> forms must be filled out completely and accurately. Any inaccuracies will be considered an invalid entry. Both forms must be turned in to the Extension Office by May 15th. Failure to turn in both forms by the May 15th deadline will result in ineligibility to show at this year's Porter County Fair, no exceptions. - H. Sheep See table below for required identification. To be eligible for exhibition, animals must be entered into 4HOnline by May 15<sup>th</sup>. For instructions on completing 4HOnline Animal ID, go to <a href="https://bit.ly/2024AnimalID">https://bit.ly/2024AnimalID</a>. Please complete the top of the enclosed worksheet and bring it with you to ID Day on Saturday, April 27<sup>th</sup> from 8:00-11:00 a.m. at the Sheep Barn. Your project volunteers will record the information gathered at ID Day so that you can take the information home and enter the information into 4HOnline.

Animal Type	Required Identification
Market Lambs	840-RFID tag *AND* 5-digit county tag
Commercial Ewes	840-RFID tag *AND* 5-digit county tag or Official USDA scrapies tag
Registered Ewes	840-RFID tag *AND* ID that matches registration papers

**NOTE:** For market lambs, commercial ewes, and registered ewes, a DNA hair sample is required for State Fair eligibility. No DNA hair sample required for County Fair eligibility.)



# ANIMAL PROJECT INFORMATION

6. Swine – To be eligible for exhibition, animals must be entered into 4HOnline by May 15th. All swine must be identified by ear notch numbers in the online system. Additionally, to be eligible for State Fair they must have a 15-digit 840-RFID tag and a DNA hair sample must be submitted to the Extension Office by May 15th. For instructions on completing 4HOnline Animal ID, go to <a href="https://bit.ly/2024AnimalID">https://bit.ly/2024AnimalID</a>. Also available at this website is a Swine ID Worksheet you can download to help you get the needed information from the barn to the computer. It is for your records only and does not get turned in. (NOTE: In 4HOnline, the 840-RFID tag may be a required field. For county only animals without an RFID tag, put all "0's" in the 840-RFID field.) (Note for State Fair exhibitors: All animals that you wish to be eligible for State Fair must be tagged with an 840-RFID tag by May 15th. If the animal already has an 840-series RFID tag, do NOT remove it. DNA hair sample collection envelopes are also available by request from the Extension Office.

TO BE ELIGIBLE FOR EXHIBITION, ANIMALS MUST BE ENTERED INTO 4HONLINE BY MAY 15<sup>TH</sup>.

Species included in 4HOnline Animal ID: Beef (Including Dairy Feeder Steers), Dairy Cattle, Goat,

Horse (Including Draft & Miniature Equine), Sheep, & Swine.

Dairy Feeder Steers, Goats, and Sheep will need to be present at ID Day as indicated, and will have until May 15<sup>th</sup> to enter the information into the online system.

ALL PAPER ANIMAL ID FORMS ARE DUE IN OUR OFFICE NO LATER THAN MAY 15<sup>th</sup>! Species with paper Animal ID Forms: Cats, Dogs, Pigeons, and Rabbits (two forms)

No paperwork due by May 15 from: Poultry-Chickens, Game Bird, Turkey, Waterfowl
